

ORBIT® GUM LA SWEEPSTAKES PROMOTION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. A VALID EMAIL ADDRESS IS REQUIRED.

- 1. ELIGIBILITY:** The ORBIT® Gum LA Sweepstakes Promotion (the “Promotion”) is offered only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older at the time of entry. Void where prohibited or restricted by law. Employees, officers and directors, and their immediate family members (spouses, siblings, parents and children, including foster and step-relations, and their respective spouses) and household members (whether or not related) of Mars Wrigley Confectionery US, LLC (“Sponsor”), TPG Rewards, Inc. (“Administrator”), The Integer Group, American Broadcasting Companies, Inc., their respective owners, parents, subsidiaries and affiliates, advertising and promotion agencies, and any companies involved in the implementation and execution of the Promotion (collectively, the “Promotion Entities”) are not eligible. By participating, each entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor (and its authorized third parties), which are final and binding on all matters relating to the Promotion.
- 2. PROMOTION PERIOD:** Promotion starts on or about 12:00:01 a.m. Pacific Time (PT) on January 1, 2020 and ends at 11:59:59 p.m. PT on March 31, 2020 (“Promotion Period”). The clock on Administrator’s server shall be the official time keeping device for this Promotion.
- 3. HOW TO ENTER:** There are two (2) ways to participate in the Promotion:

 - a. Enter with Purchase.** During the Promotion Period, an eligible entrant (“Entrant”) must purchase any package of ORBIT® gum (a “Qualified Purchase”), and upload a photo of the receipt for that Qualified Purchase at sweepstakes.orbitgum.com (“Website”) by 11:59:59 p.m. PT on April 7, 2020 (“Submission Deadline”). Visitors to the Website will be required to follow the online directions to: (i) submit their birthdate; (ii) submit his/her first and last name, street address, state, city, ZIP code, email address, daytime telephone number; (iii) agree to be bound by these Official Rules and the decisions of the Sponsor and its authorized third parties; and (iv) upload a photo of the receipt showing a Qualified Purchase to the Website. The photo must clearly show all of the following (i) the name of the U.S. retailer where the Qualified Purchase was made; (ii) date of Qualified Purchase (must be made between January 1, 2020 and March 31, 2020; (iii) time of Qualified Purchase; (iv) receipt total; and (v) purchase of one (1) or more Qualified Purchase packages. After successful completion of the above steps, Entrant will receive one (1) entry into the Promotion (“entry”). **Limit one (1) entry per receipt, regardless of the number of Qualified Purchases contained on the receipt.** All entries must be received by the Submission Deadline. Entrants must keep a copy of

their receipt. Sponsor reserves the right to require a participant to provide original receipt for verification purposes upon request. **Important: If the Entrant is participating in the Promotion via a mobile device, message and data rates may apply.** The Entrant should consult his/her wireless service provider regarding its pricing plans. Participation may not be available on all mobile devices, as not all mobile devices or cellular telephone providers have the capabilities or carry the service necessary to participate in this method of entry.

- b. Mail-in Method.** To enter without a Qualified Purchase, legibly hand-print your first and last name, street address, state, city, ZIP code, email address, daytime telephone number and birthdate on a plain piece of white paper, sign your name on the paper in ink, and mail it postage prepaid to: ORBIT® Gum LA Sweepstakes Entry, P.O. Box 6050, Dept. 42076, Douglas, AZ 85655. Mail-in entries must be postmarked by March 31, 2020 and received by April 7, 2020. By submitting a mail-in entry with your signature, you agree to be bound by these Official Rules and the decisions of Sponsor and Administrator. You will receive one (1) entry per mail-in request (“entry”).

Limit one (1) entry per person or e-mail address per day, regardless of the method of entry. A “day” is defined as 12:00:01 a.m. PT through 11:59:59 p.m. PT. You may enter the Promotion under one name/e-mail/address only. In the event of a dispute about entries submitted by multiple individuals using the same email account or address, the entry will be deemed to have been submitted by the authorized account holder of the email account used to enter the Promotion at the actual time of entry. The authorized account holder is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Multiple entries per person/email/address/wireless telephone number in excess of the daily entry limit, or any use or suspected use of artifice, bots, robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to sweepstakes entry services/clubs) are prohibited; any Entrant using/benefitting from such methods will be disqualified and their entries voided. Proof of entry submission is not proof of receipt or eligibility for this Promotion.

- 4. SELECTION OF WINNERS/ODDS:** Winner will be selected in a random drawing conducted by Administrator on or about April 17, 2020, from among all eligible entries received. Odds of winning depend on the number of eligible entries received.

5. PRIZES AND APPROXIMATE RETAIL VALUE (“ARV”):

- a. Grand Prize (1):** Trip for two to Los Angeles, California to attend a live taping of “The Bachelorette” television show (“Show”), which is currently scheduled to take place in July/August 2020 (exact dates to be determined) in or around Los Angeles, California. Grand Prize package consists of two (2) tickets to the Show taping (location/seat to be determined by Sponsor); round-trip coach class air transportation for the winner and

one (1) adult guest from a major commercial airport near the winner's home to Los Angeles, CA (airports determined by Sponsor; if Grand Prize winner resides within two hundred fifty (250) miles of destination, Sponsor may provide ground transportation in lieu of air transportation); three (3) nights' hotel accommodations in the form of one (1) standard room, double-occupancy (hotel to be determined solely by Sponsor) (room and tax only); and four (4) \$500 prepaid debit cards. Exact date and location of Show taping are subject to change. There is no retail value associated with the Show taping portion of the Grand Prize and exact seat location is at Sponsor's sole choosing. ARV: \$15,000.

- b. **First Prizes (100):** Free ORBIT® Gum For A Year. This will be provided to winners in the form of one (1) Single pack of gum (flavor selected by Sponsor) a week for fifty-two (52) weeks. Winner will receive the full year supply in one shipment of fifty-two (52) packs. ARV: \$50.

The ARV of all prizes offered in the Promotion is \$20,000.

Prize Restrictions. Limit one (1) First Prize per Entrant. No transfer, assignment or substitution of prize (in whole or in part) is allowed, except that Sponsor reserves the right to substitute a similar prize of equal or greater value. Grand Winner and guest must be able to travel on the dates specified by Sponsor to coincide with Show taping (with projected travel dates being during July/August 2020); no alternate travel dates are available. All arrangements for the Grand Prize trip must be arranged/booked with Sponsor's agent. Winner and guest must travel together on the same itinerary; travel must originate and terminate at the same airport/location. If Winner is a minor in his/her state of residence, he/she must be accompanied by his or her parent or legal guardian as the guest. Failure to do so may result in forfeiture of the Show taping portion of the Grand Prize. Producers of the Show may also have Grand Prize Winner and their guest sign a separate liability and publicity release, and will be subject to Show's security procedures and any other applicable policies. The Show reserves the right to suspend or cancel the participation of the Grand Prize Winner or guest due to non-compliance with any security procedure or inappropriate behavior or misconduct. Sponsor reserves the right to remove or to deny entry to winner and/or his/her guest if either winner or his/her guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person or cause damage to or property loss at the event. All prize claims are subject to verification by Administrator. Regardless of whether or not you receive a potential winner message, you are not a winner until your prize claim has been timely received and verified by the Administrator, your entry and eligibility have been verified, and you have complied with these Official Rules. Each potential winner may be required to furnish proof of identification and other proof of eligibility under these Official Rules and may also be required to execute and return (or potential winner's parent or legal guardian if potential winner is a minor in his/her state of residence) an

Affidavit of Eligibility/Publicity Release within a time period specified by Administrator. Prize will be forfeited if prize claim is not timely received according to the instructions and by the prize claim deadline provided in the notification. The Promotion Entities are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking, or by any of the equipment or programming associated with or used in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft, destruction or unauthorized access to any website(s). Promotion Entities are not responsible for any injury, including death, disability or other damage, whether personal or property, to Entrants or to any person's computer or mobile device related to or resulting from participating in the Promotion and/or accepting a Prize. If, for any reason, the Promotion is not capable of running as planned, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion, including the selection of prize winners in a manner it deems fair and reasonable from among eligible entries received prior to such cancellation, termination, modification or suspension. If because of technical, typographical, mechanical or other errors or for any other reason, there are more claims for a prize than prizes offered as stated in these Official Rules, a random drawing will be held among all eligible claimants in such category to award such prize.

Sponsor reserves the right to disqualify any individual in its sole and absolute discretion including but not limited to any individual suspected of, or found, in its sole opinion, to be tampering with the operation of the Promotion; to be acting in violation of these Official Rules; or to be acting in an unsportsmanlike manner or with the intent to disrupt the normal operation of a Promotion.
